	If students ever wish to change from the Double Degree, Joint Degree or MSc program they are enrolled in to another MSc program, they must make a Special Request through their personal area (e-SCA) as soon as possible (i) for this request to be duly analyzed by the Academic Direction of the MSc program they wish to join.		
	(i) ideally before the end of the first semester of the program, so that expected program duration might be kept if possible.		
	In the event of a positive answer from the Academic Direction, monthly tuition fees will be revised (according to the new MSc program tuition fees):		
	- <u>in the case of a change from Double Degree or Joint Degree to MSc program</u> : after the end of the semester students are enrolled in;		
	- <u>in the case of a change from MSc to another MSc program</u> : in the month after program change authorization was given.		
	Please note that:		
	- there shall be no retroactive financial adjustments of any kind [tuition fees and/or scholarship related discount] (ii), even if and when monthly tuition fees of the new program are lower than the ones of the previous program;		
	- percentage discount of yearly scholarship, if any and if still applicable, will apply to the new monthly tuition fees for the remaining duration of the scholarship.		
	(ii) except if you joined a Double Degree program through a second call process (please contact the Student Affairs - International Relations Office team for further information in that case)		
7. FINAL SETTLEMENT OF TUITION FEES	In the event of having exceeded the maximum amount of ECTS in coursework allowed in their MSc program (69 ECTS for MSc in Economic and 67 ECTS for all other MSc programs; cf. 8. NOTES below), students will have to settle - prior to their thesis defence - the extra cost corresponding to the ECTS in excess, according to the following formula:		
	<i>Extra cost = (number of ECTS in excess) × [ECTS monthly value of the student's MSc program (calculated on a semestral basis)] × 5 months (= 1 semester)</i>		
	Should students have changed programs during their academic journey, the maximum amount of ECTS allowed as well as the ECTS monthly value to be considered will be the ones of the final MSc program students are enrolled in.

8. NOTES

(*) These amounts are updated every year.

(1) Penalty fee for delayed thesis is due each time one of the 4 existing thesis deadlines is postponed (January, April, June & September):

Failure to deliver thesis in January will generate a penalty fee for delayed thesis in April.

Failure to deliver thesis in April will generate a penalty fee for delayed thesis in May/June.

Failure to deliver thesis in May/June will generate a penalty fee for delayed thesis in September.

Failure to deliver thesis in September will first generate a new registration fee and then a penalty fee for delayed thesis in January.

a) MSc in Economics: regular tuition fees allow students to register in courses / modules / workshops at CATÓLICA-LISBON up to 69 ECTS without any extra payment. To obtain the degree, students normally only need to register for 60 ECTS credits.

b) All MSc (except MSc in Economics): regular tuition fees allow students to register in courses / modules / workshops at CATÓLICA-LISBON up to 67 ECTS without any extra payment. To obtain the degree, students normally only need to register for 60 ECTS credits.
